- b) Discussion on Lincoln St. development Status as noted above (IV.a.2.C), but bigger discussion was that the larger, overall Traffic Study & Planning is needed. Points made:
 - 1. Traffic Study should be driven by community, with Board reacting to & supporting Puget community raising issues. Study & Planning here (and with other CoB Infrastructure Planning)

- lacks whole system approach, seems narrow, not comprehensive, falls short. (e.g. mentioned Lincoln St. Dev Plan only to Lincoln centerline)
- 2. Karen reported Lakeway Mobile Home HOA writing letter to circulate for signatures, and will bring to meeting if ready.

V. New Business

- a) By-Laws Review Diana had no specific issues but suggested it's time to review, Steve asked Board to review and be ready to discuss at next Board meeting any issues found.
- b) Homeless Coalition Karen raised, Diana recommended presentation as seen at MNAC although may be long, Steve to pursue more info as to fit for September's Meeting.
